

# **EXPLANATORY MEMORANDUM 25 September 2014**

#### **AMENDMENT 2015**

Draft amendments of Schedules Nos. 1, 2, 3 and 4 to the Customs and Excise Act, 1964 (the Act), in respect of the phase-down of duties for 2015 in terms of the EFTA Trade Agreement, reports made by the International Administration Commission (the Commission), as well as some technical amendments.

The amendments in Part 1 of Schedule No. 1 include-

Deletions: 40

Substitutions: 1045

Insertions: 160

The proposed amendments for 1 January 2015 are in respect of -

- the phase-down of the rates of duties for 2015 in terms of the EFTA Trade
   Agreement with Iceland, Norway, Switzerland and Liechtenstein;
- the reduction in the general rate of duty on paper and paperboard in terms of the recommendation made by the Commission in Report No. 151; and
- various technical amendments to Schedules Nos. 1, 2, 3 and 4 to the Act.

The amendments to Schedule No. 1 to insert 8-digit subheadings for fowl of the species *Gallus domesticus* classifiable in tariff subheadings 0207.1 will be implemented with effect 1 February 2015. The implementation of these amendments is postponed for technical reasons.



### 1. The phase-down of duties in terms of the EFTA Trade Agreement

In terms of the EFTA Trade Agreement, which entered into force on 1 May 2008, South Africa has an obligation to amend the rates of duties on certain products listed in Part 1 of Schedule No. 1 to the Act, on an annual basis, with effect from 1 January of a particular year.

The phase-down of duties in terms of the EFTA Trade Agreement for 2015 relates to the following –

- fish and other marine products in Annex IV, table 3 categorised as List 4;
- industrial products in Annex VII, table 1 categorised as List 3, List 4 and List 5;
- agricultural products in Annex VII, table 2 categorised as List 4 and List 5; and
- agricultural products in Annex I of the Agricultural agreement between the SACU States and Switzerland, table 1 categorised as List 3.

# 2. Reduction in the rate of duty on paper and paperboard of tariff subheading 4811.41.90

The general rate of duty on paper and paperboard of tariff subheading 4811.41.90 is reduced from 2% to free in terms of the recommendation made by the Commission in Report No. 151 dated 8 February 2006.



#### 3. Technical amendments to the Schedules of the Act

The technical amendments mentioned in the following paragraphs are in respect of-

### 3.1 Additional tariff subheadings in Part 1 of Schedule No. 1

Additional tariff subheadings have been added in Chapters 2, 4, 15, 30, 32, 33, 38, 39, 54, 70 and 85 of Part 1 of Schedule No. 1 for the reasons indicated in the following subparagraphs:

# 3.1.1 Request for separate 8-digit tariff subheadings to provide for Wagyu beef

The Wagyu Breed Society of South Africa (the applicant) applied for the creation of 8-digit tariff subheadings to provide for Wagyu beef. The ban on meat export from South Africa (SA) was lifted in February 2014. Wagyu breeders may now export and earn foreign currency.

The applicant motivated that Wagyu beef is being imported into SA leading to the industry losing a significant market share. The new 8-digit tariff subheadings will enable the industry to be more competitive and create jobs. It will also ensure accurate statistics on imports.

### 3.1.2 Request for separate 8-digit tariff subheadings for fowl of the species *Gallus Domesticus* classifiable in tariff subheadings 0207.1

F.C Dubbelman & Associate CC on behalf of South African Poultry Association (SAPA) (the Applicant) submitted a request for the creation of separate tariff subheadings in order to monitor under invoicing by importers in the poultry industry.

The Department of Agriculture was consulted and they confirmed that that the creation of separate tariff subheadings will not impact on the issuing of permits for the importation of the products in question.

The creation of separate 8-digit subheadings will assist SARS with implementing effective reference price monitoring system for imports.

### 3.1.3 Separate 8-digit tariff subheadings to provide for filled aerosol products

The Aerosol Manufacturers Association (AMA) applied for the creation of separate tariff subheading for all filled aerosol products. The key categories range from personal care including deodorants, haircare and shaving foams, home care including polishes and air fresheners, pharmaceuticals, pesticides, food, lubricants and spray paints.

According to the applicant, South African industry is under tremendous pressure as importers misdeclare under the 6-digit international level which is not clear on packaging type.

Additional Note 2 has been added to read "for the purpose of this Chapter, the expression solar glass has been included to mean glass sheets with an iron content of less than 300 ppm and a solar transmittance of more than 88% (measured according to ISO 9050: AM1,5".
