

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES  
TO THE CUSTOMS AND EXCISE ACT, 1964**

**These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.**

2921.44.10 2921.44.20 2921.44.30 2921.51.30 2934.20 2934.20.15 2934.20.90	The effect of this amendment is that the provisions for octylated diphenylamine, derivatives of p-phenylenediamine and on 2-Mercaptobenzothiazole have been reduced to free and are therefore deleted in order to simplify the tariff structure.
3919.10.06 3919.90.06	The effect of this amendment is that an 8 digit subheading has been created for cellular polyurethane, self-adhesive on both sides, commonly known as double sided adhesive tape at a rate of duty of free.
3919.10.45	For the purpose of tariff simplification the 8-digit subheading is deleted.
7304.39.35 7304.59.45	The effect of this amendment is that the general rates of duty on seamless pipes, of iron or steel classifiable under subheadings 7304.39.35 and 7304.59.45 are reduced to free.
9004.10	The effect of this amendment is that the general and EU rates of duty on sunglasses are reduced from 10% and 8,8% respectively to free.
