

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

4011.10	The period for the provisional payment imposed in relation to anti-dumping duty on new pneumatic tyres, of rubber, of a kind used on motor cars (including station wagons and racing cars) originating in or imported from China (excluding those originating in or imported from Aeolus Tyre Co. Ltd., Triangle Tyre Co. Ltd., Giti Tire (Anhui) Ltd. en Shandong Chengshan Group Co. Ltd.) is extended to 26 April 2007 .
4011.20.15	The period for the provisional payment imposed in relation to anti-dumping duty on new pneumatic tyres, of rubber, of a kind used on buses and lorries, with a load index not exceeding 121, originating in or imported from China (excluding those originating in or imported from Aeolus Tyre Co. Ltd., Triangle Tyre Co. Ltd., Giti Tire (Anhui) Ltd. en Shandong Chengshan Group Co. Ltd.) is extended to 26 April 2007 .
4011.20.25	The period for the provisional payment imposed in relation to anti-dumping duty on new pneumatic tyres, of rubber, of a kind used on buses and lorries, with a load index exceeding 121, originating in or imported from China (excluding those originating in or imported from Aeolus Tyre Co. Ltd., Triangle Tyre Co. Ltd., Giti Tire (Anhui) Ltd. en Shandong Chengshan Group Co. Ltd.) is extended to 26 April 2007 .
