TO THE CUSTOMS AND EXCISE ACT, 1964**

IMPOSITION OF PROVISIONAL PAYMENT (PP/128)**

Under section 57A(2) of the Customs and Excise Act, 1964, the provisional payments in relation to safeguard duties imposed through Government Notice No. R. 445 of Government Gazette No. 29889 dated 11 May 2007 is hereby reduced from 160 percent to 27 percent.

The reduction will come into effect on the date this notice is published in the Government Gazette and will remain effective up to and including 27 November 2007.
