

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

22 AUGUST 2008

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

<i>Provision</i>	<i>Note</i>
3926.90.05	The effect of this amendment is that the rate of duty on sheets consisting predominantly of polyethylene, with one side not exceeding 160 mm and the other side not exceeding 465 mm, with 16 flat plastic spoons affixed to it, has been reduced to free.
215.12/8301.40/01.06 215.12/8302.41/01.06	The effect of this amendment is that the anti-dumping duties on mortise locks, 2, 3 and 4 lever, of base metal, with or without handles (excluding those with handles of copper-zinc base alloys as defined in subheading Note 1(a) to Chapter 74 in Schedule No. 1, stainless steel or aluminium), used for doors for buildings and door handles, of base metal (excluding copper-zinc base alloys as defined in subheading Note 1(a) to Chapter 74 in Schedule No.1, stainless steel or aluminium), suitable for doors for buildings, is amended to exclude that imported from Ningbo Jiangbei Minjin Lock Factory from the payment of the anti-dumping duties and extended until further notice. The effect of this amendment is that:
9506.99.10 9506.99.90	new subheadings are created for collapsible swimming pools and paddling pools, of polymers of vinyl chloride (PVC), at a rate of duty of 10% and other goods not elsewhere classifiable in this subheading; and
320.06/3920.43/01.06	a new rebate provision is created for a full rebate of duty on plates, sheets, film, foil and strip, of polymers of vinyl chloride (PVC), containing by mass not less than 6 percent of plasticisers.
307.04/3920.49/02.06	The effect of this amendment is that a provision for a rebate of duty in respect of plates, sheets, film, foil and strip, of polymers of vinyl chloride containing by mass less than 6 per cent of plasticisers, with a width not exceeding 160 mm and a thickness of 0,36 mm, printed, for the manufacture of moulded trays for the packing and conveyance of goods classifiable under tariff subheading 3923.90.90, is created.
311.20/5407.61/01.06	The effect of this amendment is that provision for a rebate of duty has now been made for "Woven fabrics, of mass of 35 g/m2 or more but not exceeding 50 g/m2, consisting of 100% non-textured polyester monofilament yarns, woven from yarns with a linear density of 15 dtex or more but not exceeding 22 dtex and with a construction of 60 threads per cm2 or more but not exceeding 80 threads per cm2, for the manufacture of women's and girls' dresses." The effect of this amendment is that new temporary provisions are inserted in Part 2 of Schedule No. 4 for;
