

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

213.03/7004.90/01.06	The effect of this amendment is that a provision for anti-dumping duty on drawn glass and blown glass, in sheets, whether or not having an absorbent or reflecting layer, but not otherwise worked, of a thickness exceeding 2,5 mm but not exceeding 6 mm (excluding optical glass), manufactured by Gujarat Borosil Ltd. and imported from or originating in India, has been deleted.
213.03/7004.90/02.06	The effect of this amendment is that a provision for anti-dumping duty on drawn glass and blown glass, in sheets, whether or not having an absorbent or reflecting layer, but not otherwise worked, of a thickness exceeding 2,5 mm but not exceeding 6 mm (excluding optical glass) (excluding that manufactured by Gujarat Borosil Ltd.) and imported from or originating in India, has been deleted.

213.03/7005.29/23.06	The effect of this amendment is that a provision for anti-dumping duty on float glass and surface ground or polished glass, in sheets, whether or not having an absorbent, reflecting or non-reflecting layer, but otherwise not worked, of a thickness exceeding 2,5 mm but not exceeding 6 mm (excluding optical glass), imported from or originating in China, has been created.
