

NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964

30 JULY 2010

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

215.02/7312.10/04.06	The provision for an anti-dumping duty on stranded wire, rope and cables, of iron or steel, not electrically insulated, of a diameter exceeding 8 mm (excluding that of wire of stainless steel, that of wire, plated, coated or clad with copper and that identifiable as conveyor belt cord), imported from Bridon International Limited, originating in or imported from the United Kingdom, is withdrawn with retrospective effect from 16 February 2009.
215.02/7312.10/11.06	The description is substituted for anti-dumping on stranded wire, of iron or steel, not electrically insulated, of a diameter exceeding 8 mm (excluding that of wire of stainless steel, that of wire, plated, coated or clad with copper or tin and that identifiable as conveyor belt cord) (originating in or imported from China, with retrospective effect from 13 February 2009.
215.02/7312.10/12..06	The description for anti-dumping is substituted on stranded wire, of iron or steel, not electrically insulated, of a diameter exceeding 8 mm (excluding that of wire of stainless steel, that of wire, plated, coated or clad with copper or tin and that identifiable as conveyor belt cord) originating in or imported from Korea, with retrospective effect from 13 February 2009.
215.02/7312.10/13..06	The description for anti-dumping is substituted on stranded wire, of iron or steel, not electrically insulated, of a diameter exceeding 8 mm (excluding that of wire of stainless steel, that of wire, plated, coated or clad with copper or tin and that identifiable as conveyor belt cord (excluding that imported from Bridon International Limited) originating in or imported from United Kingdom, with retrospective effect from 13 February 2009.
215.02/7312.10/14..06	The description for anti-dumping is substituted on stranded wire, of iron or steel, not electrically insulated, of a diameter exceeding 8 mm (excluding that of wire of stainless steel, that of wire, plated, coated or clad with copper or tin and that identifiable as conveyor belt cord originating in or imported from Germany, with retrospective effect from 13 February 2009.
