NOTES REGARDING AMENDMENTS TO THE SCHEDULES TO THE CUSTOMS AND EXCISE ACT, 1964

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

215.02/7318.15/01.06	The effect of this amendment is that the rate of anti-dumping duty on bolts, of iron or steel, with hexagon heads (excluding bolts of stainless steel, bolts fitted with base metal expansion sleeves and bolts identifiable for use solely or principally on aircraft), of a width of 6 mm or more but not exceeding 36 mm and a length of 10 mm or more but not exceeding 400 mm, whether or not with their nuts and washers (excluding those manufactured by Ningbo Jinding Piece Company Limited), is increased from 29% of duty to 55,4%, as recommended in ITAC's Report No. 362.
215.02/7318.16/01.06	The effect of this amendment is that the rate of anti-dumping duty on hexagon nuts, of iron or steel (excluding dome nuts, nuts with non-metallic inserts, nuts of stainless steel, nuts identifiable for use solely or principally on aircraft and collared nuts), of a thread diameter of 6 mm or more but not exceeding 36 mm (excluding self-locking nuts of a thread diameter exceeding 10 mm), is increased from 36% of duty to 122,7%, as recommended in ITAC's Report No. 362.
