PROCLAMATION*by the**President of the Republic of South Africa***No. 56, 2010****THE REAPPOINTMENT OF MEMBERS OF THE TAX COURTS**

Whereas the persons mentioned in Schedule A to this Proclamation are suitable for reappointment as members of the Tax Courts, constituted in accordance with the provisions of section 83(3) of the Income Tax Act, 1962 (Act no.58 of 1962) ("the Act");

Now therefore under the powers vested in me by section 83(5)(a) and (b) of the Act, I do hereby reappoint the persons mentioned in Schedule A to this Proclamation as members of the Tax Courts for another period of five years from the date of this Proclamation, subject to the provisions of the proviso to section 83(5)(a) of the Act.


