

# I-OECD, ABAKWA-SARS KANYE NOMGCINIMAFI KAZWELONKE BAYAQHUBEKA NOBUDLELWANO BOKUQINISA UKUBAMBISANA KWEZENTELO

**Pretoria, 11 Masingana 2019** – Namuhla, iNhlangothi yokuBambisana kwezoMnotho neNtuthuko i-Organisation for Economic Cooperation and Development (OECD), uPhiko lweziMali eziNgenayo eNingizimu Afrika (SARS) kanye noMgcinimafa kaZwelonke (uMgcinimafa kaZwelonke) basayinde iSivumelwano sokuSebenzisana (MoC), bevuma ukuqhubeka nokusebenzisana ezindabeni zokuthelisa. I-MoC izosebenza kuze kube uZibandlela wonyaka wezi-2023.

"Kungenxa yemisebenzi yokubambisana efana nalena esingene kuyo ne-OECD esingathuthukisa ngayo imizamo yethu yokuqoqa intela futhi siqinise intando yeningi yethu," kusho uDondo Mogajane, uMqondisi-Jikelele kuMgcinimafa kaZwelonke.

UMark Kingon uphawule ngokuthi ukubambisana kwe-OECD–South African ezindabeni zeNqubomgomo nokweNganyelwa kweNtelo kule minyaka eyedlule kube wusizo kakhulu kubo bonke ababandakanyekayo.

"Ukwengeza lokhu ngeminye iminyaka emihlanu kube yinto elula ukuyenza. Ngijabula ngokuqhubeka kobudlelwano obuhleliwe i-MoC ne-OECD abazokuhlazeka abakwa-SARS, ikakhulukazi ekugxileni endleleni ethinta konke okuthinta uhulumeni ekwenganyelweni kwentelo, kanjalo nokucija amakhono abasebenzi bethu ekutheliseni kwamazwe omhlaba".
