Namuphi uMkhiqizi weziMoto kanye/noma umkhiqizi wemishini (Motor Vehicle Manufacturer and/or Original Equipment Manufacturers (OEMs)) ongenisa izingxenywe zemishini ezosetshenziselwa ukukhiqiza izimoto ezithile kumele athole imvume yendawo ekhethekile yokukhiqiza i-Special Manufacturing Warehouse bese ebhalisela ukudluliselwa kokusetshenziswa ekhaya i-Home Use Processing ngaphansi kwe-Rebate Item 317.03.
