

## Kuyini?

Umnikelo ukukhishwa kwanoma yini ngesihle (mabhala noma engakhokhelwa) kubandakanya ukunikezela noma ukulahla ilungelo ngesihle. Uma umuntu owemukela umnikelo (onikelelwayo) kukhona akukhiphayo naye, lokho akuseyiwo umnikelo.

Kuba umnikelo uma kuthotshelwe yonke imithetho ngokomthetho mayelana nomnikelo (ngokwesigaba 55(3)).

## Isilinganisonani seNtelaminikeloo

Ngenyanga kaNhlolanja 2018 nezinyanga ezindulelayo, ibihleli kusilinganisonani esimi ndawonye esingu-20%.

Kusukela mhla lu-1 kuNdasa 2018, intelamnikelo ibizwa ngesilinganisonani elingu-20% wenani lempahla enikelwayo engevile ku-R30 million, nangezinga elingu-25% enanini elingaphezulu kuka-R30 million (isigaba 64(1)). Sicela uqaphele lokhu okulandelayo –

- ukuze kutholakale izinga lomkhawulo elingu-R30 million, izinga lempahla enikeliwe liqala kusukela mhla lu-1 kuNdasa 2018 kuze kube usuku lomnikelo wamanje. Namiphi iminikelo eyenziwe ngaphambi komhla lu-1 kuNdasa 2018 kumele ibhekwe;
- izinga lenani lempahla lokuthola izinga lomkhawulo elingu-R30 million libalwa emva kokubanjwa kwakho konke okuxegiselwayo (isigaba 56);
- lapho onikelayo edlulile ezingeni elingumkhawulo elibekiwe elingu-R30 million, yonke iminikelo elandela lapho izotheliswa ngesilinganisonani esingu-25%.

## Okuxegiselwayo

Zine (4) izinhlobo zokuxegiselwa –

**Uhlobo Iokuqala** - iminikelo ethile ayiyikhokhi nhlobo intelamnikelo. Isibonelo, umnikelo owenzelwe umlingani; inhlango yomphakathi egunyaziwe; uhlaka lukahulumeni; umnikelo okhanselwe ezinyangeni eziyisithupha (6) kusukela ngosuku owaqala ngalo ukusebenza; njll. (isigaba 56(1)).

**Uhlobo Iwesibili** - lapho onikelayo engeyena umuntu nje (isibonelo, izinkampani namaqomangcebo), iminikelo exegiselwe igcina ngezipho ezingevile enanini eliphelele elingu-R10 000 ngonyaka wokuhlol (isigaba 56(2)(a)).

**Uhlobo Iwesithathu** - U-R100 000 wokuqala wempahla enikelwayo onyakeni wokuhlola ngamunye owenziwa ngumuntu nje awuthelisa intelaminikelo (isigaba 56(2)(b)).

**Uhlobo Iwesine** - okungathelisa intelamnikelo yiminikelo weqiniso enikelelwe ukondliwa kwanoma imuphi umuntu. Lokhu kuxegiselwa kugcina kulokhu uKhomishana akubona kufanele (isigaba 56(2)(c)).

### **Iyisibopho sikabani intelamnikelo?**

Intelaminikelo iseberza kunoma ubani (isibonelo: umuntu ngamunye, inkampani noma iqomangcebo) bakuleli. Ngakho, abangebona abakuleli abayikhokhi intelamnikelo.

Umuntu onikelayo (umnikeli) uyena onesibopho sokukhokha intelamnikelo, kodwa uma umnikeli ehluleka ukukhokha intela esikhathini esibekiwe, umnikeli nalowo onikelelwayo bobabili baba nesibopho sentela (isigaba 59).

Noma ingasiphi isikhathi uKhomishana angase ayalele ukuba kwenziwe inqubo yokuhlolola intelamnikelo kumnikeli nakonikelelwayo (noma bobabili). Kubandakanya nokuthi uma uKhomishana enganelisekile ngokuthi alikhokhwanga ngokugcwelle inani lentelamnikelo, angacela kwenziwe inqubo yokuhlolola lelo nani elisele. Inkokhelo eyenziwe umnikeli noma onikelelwayo izosigcwala lesi sikweletusibopho esihlanganisile (isigaba 60(5)).

### **Yiziphi izinyathelo okumele ngizithathe?**

Emva kokwenza umnikelo kumele agcwaliise ifomu lokubuyisa intelamnikelo ([i-IT144 - Ukudalula komnikeli/konikelelwayo](#)) bese ulithumela egatsheni lakwa-SARS eliseduze lihambisane nobufakazi bokuthi ukhokhile. Intelaminikelo kumele ikhokhwe ngokusebenzisa i-eFiling.

### **Kufanele uyikhokhe nini?**

Intelaminikelo kumele ikhokhwe ekupheleni kwenyanga elandela inyanga okwensiwe ngayo lowo mnikelo noma izikhathi ezengeziwe ngokuvuma kwabakwa-SARS (isigaba 60(1)).
