



ISITATIMENDE SABEZINDABA ESIHLANGANISIWE

UMGCINIMAF A KAZWELONKE KANYE NOPHIKO LWEZIMALI EZINGENAYO ENINGIZIMU AFRIKA

EKUKHISHWENI KOHLELO LONYAKA LWE-12 LWEZIBALO ZENTELA

PRETORIA, NGOLWESIHLANU 20 KUZIBANDLELA 2019

UMgcinimafa kaZwelonke kanye noPhiko IweziMali eziNgenayo eNingizimu Afrika bashicilele uhlelo lonyaka we-12 /weziBalo zeNtela.

Uhlelo lowezi-2019 iuhlinzeka ngohlolojikelele Iwentela yemali engenayo eqoqiwe kanye nolwazi Iwamaphepha entela Iweminyaka yentela yangowezi-2015 kuya kowezi-2018, kanjalo neminyaka yezimali yangowezi-2014/15 kuya kowezi-2018/19.

Ukuwa kwamandla omnotho ngonyaka wezi-2018 kwaholela ekukhuleni kancane kwemali engenayo eqoqwayo, okuholele ekunukeni kokubuyekezwa kokwehliswa kwesiphokophele kukho ngokwemali engenayo. Yize izimali ezingene ngohlelo Iwentela ihambisana nomnotho, ngokwesilinganiso, ukukhula kuntela yemali engenile kungaphezulu kokukhula komnotho. Amaphuzu asemqoka ohlelwani lowezi-2019 yilawa:

- Kuqoqwe intela yemali engenayo efinyelela ku-R1 287.7 billion, ekhula unyaka nonyaka ngemali engu-R71.2 billion (5.9%) eyeyamiswe kakhulu yiNtela yeMali eNgenayo yomuntu i-Personal Income Tax (i-PIT) ekhule ngo-R30.9 billion (6.7%):
 - I-Personal Income Tax (PIT) iku-38.3%, Corporate Income Tax (CIT) iku- 16.6% kanti i-Value-added Tax (VAT) iku- 25.2%, kanti uma zihlangene iyona enemithombo eminingi yentela yemali engenayo kanti futhi ifaka 80.1% wentela yemali engenayo eqoqiwe isiyonke.
 - Intela yemali engenayo ikhule ngesilinganiso sonyaka esihlanganisiwe esingu- 6.9% ngesikhathi sonyaka wezi-2014/15 kuya kowezi-2018/19. Inani lentela

uma liqhathaniswa neGDP linyuke kakhulu lisukela ku-25.5% ngonyaka wezi-2014/15 laya ku-26.2% ngonyaka wezi-2018/19 (okunyuke ngamaphuzu amaphesenti ayi-0.65).

- KuSahluko 2: i-PIT, ukuhlonzwa kwabantu nendawo ekuhlolweni kwabakhokhintela abahlolwe kwaze kwaba sekupheleni kukaNcwaba wezi-2019 kwaveza imiphumela ethakazelisayo:
 - 2 680 449 (54.5%) wabakhokhintela abahloliwe bekungabakhokhintela abangabantu besilisa; 2 236 580 (45.5%) bekungabantu besifazane;
 - 1 331 419 (27.2%) wabakhokhintela abahloliwe bebephakathi kweminyaka engama-35 kuya kwengama-44 yobudala; kanti
 - 1 976 674 (40.2%) wabakhokhintela abahloliwe babebhaiswe e-Gauteng, kulabo abayi-636 460 bahlala ku-Johannesburg Metro kanti babetheliswe kungeniso eliyidonswantelo elijwayelekile elingu-R446 838;
- Izibalo kuSahluko 3 mayelana ne-CIT ziveza ukuthi ezinkampanini ezingu-814 151 ezihloliwe kuze kube sekupheleni kukaNcwaba 2019 ngonyaka wentela wangowezi-2017, 24.3% zibe zinhle kungenisomali eliyidonselwantela. Elinye ingeniso eliyidonselwantelo elingu-48.3% belilingana nemali engekho kanti esele engu-27.4% zibike ukulahlekelwa emva kokuhlolwa;
- Isahluko 4 siveza ukuthi ngonyaka wezi-2018/19, 77.2% wabathengisi abakhokha i-VAT kwakuyizinkampani noma ama-close corporation. Zibe negalelo elingu-92.3% kuzinkokhelo ze-VAT kuleli zaphinde zakhokha izimali ezibuyiswayo ze-VAT ezingu-90.4%. Yize abantu (abanikazi bezinkampani ngabodwana) benza u-17.3% wabathengisi, babe negalelo elingu-3.0% kuzinkokhelo ze-VAT kuleli baphinde bathole u-1.3% wezimali ezibuyiswayo ze-VAT.
- Njengoba kuchaziwe kuSahluko 5, i-VAT yempahla engenayo kanye nentela yoMnyango wokuThelisa yikho okukhombise ukukhula okukhulu ngonyaka wezi-2018/19 uma kuqhathaniswa nonyaka wezi-2017/18. Kube ngu-13.6% kanye no-4.3% wenani eliphelele leNtela yemali engenayo ngokulandelana; okube ngu-17.9% uma ihlanganisiwe, ebihambisana nevamile kule minyaka emihlanu eyedlule. Ukwabiwa kwalezi zintela ku-GDP kunyuke kwaya ku-4.7% kusuka eminyakeni emihlanu eyendulela lo ku-4.6% ovamile, i-VAT yempahla ethelekiswayo ibe ngu-3.6% kwathi iNtelo yoMnyango wokuThelisa yaba ngu-1.1% ngonyaka wezi-2018/19.
 - I-VAT yempahla ethelekiswayo ezimbonini ezi-3 ezihamba phambili ekubeni negalelo emnothweni zenza u-87.8% wesamba esiphelele, lezo zimboni yilezi

izitolo ezihwebayo i-Wholesale and Retail Trade, imboni yokupheka nokuhlalisa abantu i-Catering and Accommodation sector (ephezulu) ku-40.0%, ilandelwe imboni ekhiqizayo (yesibili) ku-30.1% kanye nosizo lokungenelela ngezimali, imishwalense, ukudayiswa kwezindlu namabhiznisi (ephexulu) ku-17.7%.

- Isilinganisonani esiphelele sentela yoMnyango wokuThelisa ngonyaka wezi-2018/19 besingu-3.1% uma siqhathaniswa nesangonyaka owedlule esasingu-3.2%. Imikhiqizo ehamba phambili enesilinganisonani esiphezulu sentela yempahla kwaba *yizicathulo nezinto zokuhloba eziwu*-24.4%; *izikhumba ziwu*-19.4%; *izindwangu nezingubo zokuggoka ziwu*-15.8%; *ukudla, iziphuzo nogwayi kungu*-11.4% kanjalo *nezimoto, izindiza nemikhumbi zingu*-7.6%.
- Okokugcina, iSahluko 6: Ezinye izintela nokuQoqwayo kuhlinzeka ngolwazi lwezintela ezifana neNtela yeNzupo i-Capital Gains Tax (CGT), iNtela yokuDlulisela i-Transfer Duty, imivuzo yemithombo yepethroliyamu i-Mineral and Petroleum Resources Royalty (MPRR), izinkokhelo ze-Southern African Customs Union (SACU) kanye nezimali ezibuyiswayo zika-Diesel. Ngonyaka wezi-2018/19, kwenziwa i-CGT engu-R17.9 billion kuyo u-R9.5 billion wawuvela kubantu ngabanye nakumaqomangcebo kanti u-R8.3 billion wawuvela ezinkampanini. Lokhu kukhombisa ukwenyuka kuka-R249 million (1.4%) ku-R17.6 billion owenziwa ngonyaka wezi-2017/18. Uma kuhlanganisiwe kwenziwe u-R142.6 billion kusukela ekwethulweni kwe-CGT kuMfumfu wezi-2001.
